APPLICATION & AGREEMENT FOR WATER SERVICE**

I/we hereby make application to the Spring Hill Water System of Spring Hill, TN (Hereinafter System) for water service.

I/we agree to pay for all water as measured by the System's meter and billed according to prevailing rates established for such class of service.

I/we agree to permit authorized agents of the System free access to the premises of the applicant for the purpose of inspecting, reading, repairing or removing meters or other property belonging to the System.

It is understood that all service is subject to the Standard Rules and Regulations of the System as from time to time may be amended for such class of service, a copy of which is open for inspection at the System's office.

WATER

On the reverse side is our rate schedule for water and sewer services. Water meters are read around the 20th of each month. We send the bills out by the 1st of each month, and you should receive your bill no later than the 5th of each month (we bill for previous month's usage). *By signing this agreement, you agree that you are responsible for paying your bill each month whether or not you receive it.* Bills incur penalty on the 15th of each month and a final notice is mailed. *Any account still unpaid by the 25th of that month will be disconnected. If service is disconnected, a \$25.00 service charge will have to be paid prior to reconnection.*

SEWER

The sewer charge is based on your water consumption. The sewer rate is higher than the water rate, as shown on the schedule on the other side of this card. A one-time sewer credit will be given for a pool fill-up if you contact us immediately following and let us know the number of gallons of water used and the date it was filled.

GARBAGE PICKUP

Garbage service is contracted through Waste Management. Your garbage will be picked up weekly on _____ . Since this is curbside service, your garbage should be placed at the street. The fee is \$9.81 per month and will appear on your monthly water bill. If your garbage is missed, please notify Waste Management as soon as possible at 1-800-257-9145. The sanitation workers only pick up garbage that is bagged or in trash containers; they will not pick up barrels or brush. They are restricted from picking up medical waste, chemical waste, paint cans, dead animals, furniture or appliances. A maximum of 10 containers per residence is picked up. Trash containers may be leased from Waste Management, just give them a call at the above number.

ALARM PERMITS

Per City Ordinance 97-4, all residents and businesses that maintain active alarm systems are required to register the alarms with the Spring Hill Police Department. There is a \$20.00 fee for new registrations and a \$10.00 annual renewal fee. The alarm owner may be cited for failure to register the alarm. Please call 931-486-3270 with any questions or more information.

By signing this card, you acknowledge that you understand and agree to all the terms and conditions listed above.

Charges are subject to increase or decrease periodically without notice.
