A RESOLUTION TO ACCEPT GRANT FUNDING FROM THE 2024 BULLETPROOF VEST PARTNERSHIP (BVP) FROM THE BUREAU OF JUSTICE ASSISTANCE FOR THE POLICE DEPARTMENT

WHEREAS, the Spring Hill Police Department applied for funding from the BVP under the Bureau of Justice Assistance for the purchase of body armor worn by police officers; and

WHEREAS, funding is allocated to purchase (15) fifteen body armor with reimbursement from the BVP at (50%) fifty percent of the cost of each body armor purchased; and

WHEREAS, the total program amount requested and awarded from BVP is \$10,140.00, which would provide the Police Department with \$5,007.31 in reimbursement; and

WHEREAS, matching funds for this grant are budgeted within the FY 2024-25 Police Department Uniform budget.

NOW, THEREFORE BE IT RESOLVED, that the City of Spring Hill Board of Mayor and Alderman approves the acceptance of the grant funding from the 2024 Bulletproof Vest Partnership for the purchase of body armor in the amount of \$10,140.00, with \$5,007.31 in reimbursement, from the Bureau of Justice.
