

ORDINANCE 14-18

AN ORDINANCE AMENDING TITLE 3, CHAPTER 2 OF THE SPRING HILL MUNICIPAL CODE TO MAKE THE FAILURE TO APPEAR BEFORE THE CITY COURT A SEPARATE OFFENSE OF CONTEMPT OF COURT

WHEREAS, the Board of Mayor and Aldermen of the City of Spring Hill, desiring that the ends of justice and court administrative efficiency be met, wish to discourage persons cited for a violation of law or lawfully notified of a violation and commanded to appear, have been subpoenaed, summoned, or otherwise ordered to appear before the City Court of the City of Spring Hill from failing to appear when the person has been issued a notice of violation of a traffic law and/or a City ordinance, or has been summoned, subpoenaed, or otherwise ordered to appear:

NOW THEREFORE,

SECTION I. BE IT ORDAINED by the Board of Mayor and Aldermen of the City of Spring Hill that Title 3, Chapter 2 of the Spring Hill Municipal Code be amended to add a Section 3-208, which shall read as follows:

3-208. Separate Offense: Failure to Appear as Contempt of Court

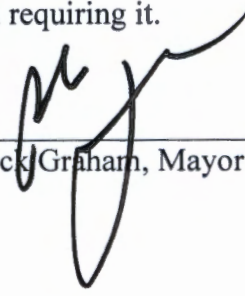
- (1) It shall constitute a separate offense for any person notified to appear in City Court to fail to appear on the date and at the time that they have been notified to appear
 - (a) when an offender has signed an agreement and waiver in lieu of arrest contained in the citation(s);
 - (b) as commanded in a notice of violation, summons, subpoena or other lawful order of the court, ordering a person to appear;
 - (c) and/or as commanded by a verbal order of the court to a person at a previous appearance by that person in court.
- (2) Upon a person's failure to appear in Court as set forth in sub-section (1)(a)-(c) above, the Court shall provide the offender with notice of a separate show cause hearing date and time at which the offender may appear and show persuasive cause for why they failed to appear in City Court on the hearing date set for the original offense, or as otherwise commanded to appear in City Court, and why

they should not be found guilty of failure to appear and contempt of City Court. However the failure to appear at the show cause hearing shall not be treated as an additional failure to appear offense, but as a default and admission of guilt on the failure to appear charge.

- (3) A violation of the separate offense of failure to appear shall result in a fine of \$50.00, plus court costs and litigation taxes, as well as a \$35.00 fee for the administrative costs associated with the scheduling, notice and adjudication of the separate contempt charge for failure to appear.
- (4) The power to punish under this section may not be used against any person who fails to appear for parking violations. (Tennessee Code Annotated §29-9-108(a)(3)).

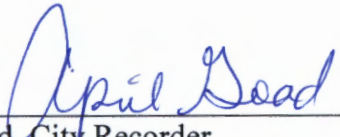
SECTION II. BE IT FURTHER ORDAINED by the Board of Mayor and Aldermen of the City of Spring Hill that if any provision of this ordinance or the application thereof to any person or circumstance is held invalid, such invalidity shall not affect other provisions or applications of the ordinance which can be given effect without the invalid provision or application, and to that end the provisions of this ordinance are declared to be severable.

SECTION III. BE IT FINALLY ORDAINED by the Board of Mayor and Aldermen of the City of Spring Hill that this ordinance shall take effect on July 1, 2014, the health, safety and welfare of the citizens of Spring Hill requiring it.

PURPOSE:

The purpose of this ordinance is to discourage persons from failing to appear for City Court, by making failure to appear a separate offense of contempt of court and collecting the applicable fine, court cost, litigation tax and an administrative fee as allowed by law.

Please see the attached spreadsheet reporting the number of cases for which defendants failed to appear for court during the past four years. There are approximately 47 FTA's (failures to appear) each month.

With this ordinance in place, when a defendant fails to appear in court, they are sent a notice via certified mail informing them of their original failure to appear, and setting a date and time for a show cause hearing. At this show cause hearing, or second court date, the defendant is given the opportunity to explain to the Judge why they did not appear on the original court date and why they should not be held in contempt of court for that failure to appear.

BACKGROUND:

Currently in City Court, if a defendant fails to appear for court, he/she is guilty by default and is charged the following:

Maximum Fine	\$50.00
Court Cost	\$75.00



State Litigation Tax	<u>\$13.75</u>
Total Collected:	<u>\$138.75</u>

If this ordinance is passed and failure to appear is considered contempt of court, in addition to being guilty by default and owing \$138.75 for the original charge, an additional charge of contempt is added to the same citation, as well as an additional fine, court cost, litigation tax and an administrative fee. The administrative fee is \$35.00 and covers the cost of the additional administrative burden associated with statutorily required notice to the defendant by certified mail, the scheduling of the charge on a separate Show Cause Hearing Docket and the expense of processing the Show Cause orders. The total due for the citation would be \$312.50, as follows:

Court Cost (for original charge)	\$75.00
State Litigation Tax (for original charge)	\$13.75
Maximum Fine (for Contempt charge)	\$50.00
Court Cost (for Contempt charge)	\$75.00
State Litigation Tax (for Contempt charge)	\$13.75
Administrative Fee	<u>\$35.00</u>
Total Collected:	<u>\$312.50</u>

FINANCIAL IMPACT:

Currently this fiscal year, there have been 431 charges for which defendants failed to appear for court. If this ordinance had been in place and failure to appear was considered contempt of court, an additional \$173.75 (fine, court cost, litigation tax & administrative fee) could have been collected for each of these 431 charges, for a total of \$74,886.25 in additional court revenue.
