

ORDINANCE NO. 03-16

Request Withdrawn

AN ORDINANCE TO ANNEX CERTAIN PROPERTY OF R. C. ALEXANDER, SUCH PROPERTY LOCATED AT 2660 AND 2774 BUCKNER LANE AND ON THOMPSON STATION ROAD EAST, AND AS SHOWN WILLIAMSON COUNTY TAX MAP 166, PARCEL 22, 23 AND WILLIAMSON COUNTY TAX MAP 154, PARCEL 62.03 CONSISTING OF A TOTAL OF 917.10 ACRES, MORE OR LESS

WHEREAS, it appears to the Board of Mayor and Aldermen of the City of Spring Hill that the prosperity of the City of Spring Hill and the affected territory will be materially retarded unless the territory is annexed to the corporate limits of the City of Spring Hill, and;

WHEREAS, the property owner listed in this Ordinance 03-16 has requested annexation in order to insure the value and availability of his property for future uses, and

WHEREAS, the natural growth area of the City of Spring Hill will include these parcels

BE IT THEREFORE ORDAINED BY THE BOARD OF MAYOR AND ALDERMEN OF THE CITY OF SPRING HILL, TENNESSEE that:

Pursuant to Tennessee Code Annotated Section 6-51-101 et seq., the property vested in property owners as hereinafter listed in Williamson County, Tennessee being a part of Williamson County Tax Map 154, Parcel 62.03, located on Thompson Station road and 2660 and 2774 Buckner Lane, totaling 917.10 acres, more or less, is hereby annexed to the corporate limits of the City of Spring Hill, Tennessee, and made a part thereof.

Annexation of said territory adjoining the City's existing boundaries is necessary for the welfare of the affected territory as well as the City as a whole.

A map showing the said territory is available for inspection at City Hall in Spring Hill, Tennessee.

This Ordinance was passed after the adoption of a plan of services for the property in conformity with and as provided by Tennessee Code Annotated, Section 6-51-102.

This Ordinance shall become effective thirty (30) days after its final passage.

This Ordinance was passed on second reading upon the recommendation of the Spring Hill Planning Commission made on June 9, 2003, and after a public hearing before the Board of Mayor and Aldermen on July 21, 2003 and after due publication in The Journal on July 1, 2003.
