


ORDINANCE NO. 96-39

**AN ORDINANCE TO AMEND THE MUNICIPAL  
ZONING ORDINANCE AND MUNICIPAL ZONING MAP  
BY THE RECLASSIFICATION OF THE PROPERTY OF  
CHERYL MAGLI ON WILKES LANE AND HIGHWAY 31  
(WILLIAMSON COUNTY TAX MAP 153, PARCEL 10)  
CONTAINING APPROXIMATELY 49.8 ACRES FROM AN  
(AG) AGRICULTURAL DISTRICT TO AN (R-2)  
MEDIUM DENSITY RESIDENTIAL DISTRICT**

**BE IT ORDAINED BY THE BOARD OF MAYOR AND ALDERMEN OF THE TOWN OF SPRING HILL, TENNESSEE** that the Spring Hill Municipal Zoning Ordinance, Ordinance No. 74-2, and the municipal zoning map of the Town of Spring Hill, as the same have been previously amended, are hereby further amended by the reclassification of approximately 49.8 acres of the property of Cheryl Magli, located on Wilkes Lane and Highway 31 (Williamson County Tax Map 153, Parcel 10) from an (AG) Agricultural District to an (R-2) Medium Density Residential District.

This amendment to the Zoning Ordinance was submitted to the Spring Hill Regional Planning Commission which, at its regular meeting held on November 11, 1996, approved this amendment. This Ordinance was adopted by the Board of Mayor and Aldermen on December 16, 1996, after a public hearing on December 16, 1996, and after due publication of notice of the public hearing in the Columbia Daily Herald and the Franklin Review Appeal on 11-24, 1996.


