

ORDINANCE NO. 88-07

THIS IS AN ORDINANCE TO AMEND ORDINANCE 88-05 BY MODIFYING CERTAIN OBLIGATIONS OF THE GARBAGE CONTRACTOR AND PRODUCERS OF REFUSE.

BE IT ORDAINED BY THE BOARD OF MAYOR AND ALDERMEN OF THE TOWN OF SPRING HILL, TENNESSEE:

That Ordinance 88-05 be amended as follows:

Section 1.04 is amended to read as follows:

1.04 Container. A receptacle with a capacity greater than twenty (20) gallons but less than thirty-five gallons constructed of plastic, metal or fiberglass, having handles of adequate strength for lifting with a tight fitting lid capable of preventing entrance by insects, the mouth of which shall have a diameter greater than or equal to that of the base; or a bag or box of sufficient wall strength to contain its contents, in place and when handled for disposal. The weight of any container and its contents shall not exceed fifty pounds (50 lbs.).

Section 1.12 is amended to read as follows:

1.12 Producer. An occupant of a residential, commercial or industrial unit which generates refuse.

Section 1.13 is amended to read as follows:

1.13 Refuse. This term shall refer to refuse or refuse and bulky waste, construction debris, and stable manner generated by producer of garbage.

Section 1.14 is amended to read as follows:

1.14 Residential and Light Commercial Refuse. All garbage and refuse generated by a producer at a residential unit or a producer at a commercial unit generating less than

seventy (70) gallons of refuse per week.

Section 3.01 (a) is amended by deleting the word "Carts" from the last sentence and inserting the words "Refuse Containers."

3.01 (b) is amended to read as follows:

3.01 (b) Equipment Required. Each residential producer shall furnish a refuse container of no more than thirty-five (35) gallons capacity and weighing no more than fifty (50 lbs.) pounds for each residential unit. Light commercial users shall furnish no more than two (2) containers each not to exceed thirty-five (35) gallons and each to weigh no more than fifty (50) pounds.


Section 3.02 is amended by deleting the words: "To be furnished by Contractor" and inserting "bag or bundle"

Section 3.03 is amended by deleting the words: "Cart" and "carts" and substituting in lieu thereof, respectively, the words "Container" and "Containers".

Section 4.02 is amended by deleting the word "their" and inserting the word "its".

Sections 4.02 and 4.08 are amended by deleting from each the word "Residential".
