

ORDINANCE NO. 88-08

AN ORDINANCE TO ANNEX CERTAIN PROPERTY IN THE VICINITY OF INTERSTATE HIGHWAY 65 IN WILLIAMSON COUNTY TO THE CORPORATE LIMITS OF THE TOWN OF SPRING HILL

BE IT ORDAINED BY THE BOARD OF MAYOR AND ALDERMEN OF THE TOWN OF SPRING HILL, TENNESSEE:

WHEREAS, a majority of the residents and property owners of the areas hereinafter described have petitioned the Board of Mayor and Aldermen of the Town of Spring Hill that these areas be annexed to its corporate limits; and

WHEREAS, it appears to the Board of Mayor and Aldermen of the Town of Spring Hill that the prosperity of the Town of Spring Hill and the territories hereinafter described which are proposed to be annexed by the Ordinance will be materially retarded and the safety and welfare of the inhabitants and property thereof endangered unless these territories are annexed to the corporate limits of the Town of Spring Hill;

NOW, THEREFORE, BE IT ORDAINED BY THE BOARD OF MAYOR AND ALDERMEN OF THE TOWN OF SPRING HILL that the following described areas be annexed to and become a part of the corporate limits of the Town of Spring Hill, to-wit:

The following described areas in Williamson County, Tennessee which lies in the vicinity of Interstate Highway 65, to-wit:

1. The property of B. E. Neal, Tax Map 27, Parcel ~~20-87~~ 20, 00
2. The property of Patricia E. Clarke, Tax Map 27, Parcel 20.01.
3. The property of Bertha Bolton, Tax Map 27, Parcel 7.
4. The property of W. E. Langley, Tax Map 27, Parcel 8.
5. The property of John W. Neal, Tax Map 27, Parcel 20.02.

BE IT FURTHER ORDAINED that the Board of Mayor and Aldermen deem the annexation of the above described property to be necessary for the welfare of the residents and property owners of the areas annexed hereby as well as the municipality as a whole.

This Ordinance was passed on the third reading after a public hearing was held on July 18, 1988, upon the question of this annexation after notice thereof was duly published in the Williamson County Leader on July 1, 1988.

This Ordinance was further adopted after the adoption of a Plan of Services for certain areas proposed to be annexed in conformity with and as provided by Sec. 6-51-102 of Tennessee Code Annotated.

BE IT FURTHER ORDAINED that this Ordinance shall become operative thirty (30) days after the final passage thereof.

BE IT ORDAINED BY THE BOARD OF MAYOR AND ALDERMEN OF THE TOWN OF SPRING HILL, TENNESSEE:

The following described areas in Williamson and Maury Counties which lie in the vicinity of Interstate Highway 65 and Port Royal Road, to-wit:

1. The property of B. E. Neal, Maury County Tax Map 27, Parcel 20.00.
2. The property of Patricia E. Clarke, Tax Map 27, Parcel 20.01.
3. The property of Bertha Bolton, Tax Map 27, Parcel 7.
4. The property of W. E. Langley, Tax Map 27, Parcel 8.
5. The property of John W. Neal, Tax Map 27, Parcel 20.02.

6. That portion of Interstate Highway 65 lying between Parcels 7 and 8 (Areas 3 and 4).

BE IT FURTHER ORDAINED that the Board of Mayor and Aldermen deem the annexation of the above described property to be necessary for the welfare of the residents and property owners of the areas annexed hereby as well as the municipality as a whole.
