

ORDINANCE 88-09

AN ORDINANCE TO ANNEX CERTAIN PROPERTY IN THE MAURY COUNTY AND WILLIAMSON COUNTY TO THE CORPORATE LIMITS OF THE TOWN OF SPRING HILL

BE IT ORDAINED BY THE BOARD OF MAYOR AND ALDERMEN OF THE TOWN OF SPRING HILL, TENNESSEE:

WHEREAS, it appears to the Board of Mayor and Aldermen of the Town of Spring Hill that the prosperity of the Town of Spring Hill and the territories hereinafter described which are proposed to be annexed by the Ordinance will be materially retarded and the safety and welfare of the inhabitants and property thereof endangered unless these territories are annexed to the corporate limits of the Town of Spring Hill;

NOW, THEREFORE, BE IT ORDAINED BY THE BOARD OF MAYOR AND ALDERMEN OF THE TOWN OF SPRING HILL that the following described areas be annexed to and become a part of the corporate limits of the Town of Spring Hill, to-wit:

1. That portion of Buckner Road which abuts on the North boundary line of the property of Gerrald Pedigo (Williamson County Tax Map 153 Parcel 29.05) from its Northwest corner to its Northeast corner.
2. That portion of the right-of-way of the Seaboard Systems Railroad which abuts any portion of the present city limits of the Town of Spring Hill included particularly that portion which begins at the Southeast corner of the property of \_\_\_\_\_, Maury County Tax Map \_\_\_\_\_, Parcel 18, extending northwardly to the Northeast corner of the property of \_\_\_\_\_, Williamson County Tax Map \_\_\_\_\_, Parcel 11.

BE IT FURTHER ORDAINED that the Board of Mayor and Aldermen deem the annexation of the above described property to


be necessary for the welfare of the residents and property owners of the areas annexed hereby as well as the municipality as a whole.

This Ordinance was passed on the third reading after a public hearing was held on July 18, 1988, upon the question of this annexation after notice thereof was duly published in the Williamson County Leader on July 1, 1988.

This Ordinance was further adopted after the adoption of a Plan of Services for certain areas proposed to be annexed in conformity with and as provided by Sec. 6-51-102 of Tennessee Code Annotated.

BE IT FURTHER ORDAINED that this Ordinance shall become operative thirty (30) days after the final passage thereof.


