

ORDINANCE NO. 86-21

AN ORDINANCE TO IMPOSE A FEE FOR THE COLLECTION OF GARBAGE
AT ALL COMMERCIAL AND INDUSTRIAL LOCATIONS

BE IT ORDAINED BY THE BOARD OF MAYOR AND ALDERMEN OF
THE TOWN OF SPRING HILL, TENNESSEE:

Section 1: That Chapter 1 of Title 8 of the Spring Hill
Municipal Code is hereby amended as follows to provide a monthly
charge for the collection of garbage at all commercial and indus-
trial establishments, by adding the following sections:

8-109. Garbage Collection Fee Imposed. There is here-
by imposed a monthly fee for the collection of garbage within the
Town of Spring Hill at all commercial and industrial locations,
including buildings containing more than three (3) residential
apartments.

8-110. Amount of Fee. The fee to be charged is as
follows: The fee schedule attached to this Ordinance as Schedule
A is hereby made a part hereof.

8-111. Application for Service. After the effective
date of this Ordinance, no garbage collection service shall be
rendered to any property except residential property consisting
of less than four (4) family units and properties devoted to
religious or other charitable purposes, until the occupant of
each property makes application therefor at the City Hall and
notifies the Recorder of the volume and number of its garbage
containers and the number of garbage collections per week
requested, and pays the charge for the first month in advance.

8-112. Due date and suspension of service on default.
The fee herein imposed shall be payable monthly in advance on the
first day of each month. Garbage collection service shall be
suspended at any location which becomes as much as fifteen (15)
days in arrears in payment of this monthly fee.

8-113. Reporting increase in volume. Any increase in
the size or number of garbage containers on any property shall be
immediately reported to the City Hall and the increase in the
monthly fee occasioned by such increase shall be determined and
paid in advance on a prorata basis according to the number of
days remaining in the month.

8-114. Penalty. Failure to make any report required under Section 8-113 is declared to be a misdemeanor.

Section 2. This Ordinance shall take effect thirty (30) days after its passage on final reading.
