

WHEREAS, it is desirable and for the public benefit that (Name of Municipality) Town of Spring Hill be able to effectively compete with private employers for qualified employees by offering adequate, standard fringe benefits of employment,

WHEREAS, among these standard fringe benefits is a method of paying for or reimbursing the cost of certain health and medical expenses, which may include dental, vision and hospital expenses; of providing life insurance; and, of providing accidental death and dismemberment insurance to elected and appointed officials, whether current or retired, and the family members and dependents of such officials and employees;

WHEREAS, it is desirable and for the public benefit that such fringe benefits be provided at a reasonable cost to the (Name of Municipality) Town of Spring Hill _____;

WHEREAS, it is desirable and for the public benefit that (Name of Municipality) Town of Spring Hill retain as much control and flexibility over the provision of such fringe benefits as is practicable;

WHEREAS, the Tennessee Interlocal Cooperation Act, T. C. A. Section 12-9-101 et seq. authorizes Tennessee political subdivisions to jointly exercise their powers, privileges, authority and financial and administrative resources;

WHEREAS, Tennessee political subdivisions are exercising their powers pursuant to the Tennessee Interlocal Cooperation Act to create a not for profit corporation to be known as the Tennessee Municipal Health Trust, Inc. by entering into an Agreement to Establish the Tennessee Municipal Health Trust, Inc. to provide a method of furnishing these employment benefits to their employees at a reasonable cost;

WHEREAS, because (Name of Municipality) Town of Spring Hill may in the future find it desirable and for the public benefit to enter into contracts with the Tennessee Municipal Health Trust, Inc., it is advisable that (Name of Municipality) Town of Spring Hill at this time enter into the Agreement to Establish the Tennessee Municipal Health Trust, Inc. pursuant to the Tennessee Interlocal Cooperation Act.

NOW, THEREFORE, BE IT RESOLVED BY THE (Legislative Body) _____ of (Name of Municipality) Town of Spring Hill AS FOLLOWS:

1. The (Name of Municipality) Town of Spring Hill shall enter into the Agreement to Establish the Tennessee Municipal Health Trust, Inc., a copy of which is attached hereto as Exhibit A and incorporated herein as though fully copied.
2. The Mayor and Recorder are hereby authorized and directed on behalf of (Name of Municipality) Town of Spring Hill to execute said Agreement to Establish the Tennessee Municipal Health Trust, Inc. and to take such other steps as may be necessary to carry out and implement this ordinance.
3. This Ordinance shall become effective upon its passage, the public welfare requiring it
