RESOLUTION PROPOSING THE FIRST NOVEMBER 1987 PLAN OF SERVICES FOR CERTAIN PROPERTIES LYING IN MAURY COUNTY AND SUBMITTING IT TO THE PLANNING COMMISSION

BE IT RESOLVED BY THE BOARD OF MAYOR AND ALDERMEN OF THE TOWN OF SPRING HILL, TENNESSEE:

WHEREAS, the property owner of one of the two the areas hereinafter described have petitioned the Board of Mayor and Aldermen of the Town of Spring Hill that this area be annexed to its corporate limits; and

WHEREAS, it appears to the Board of Mayor and Aldermen of the Town of Spring Hill that the prosperity of the Town of Spring Hill and certain areas lying in Maury County will be materially retarded and the safety and welfare of the inhabitants and property endangered unless the areas are annexed to the Town of Spring Hill and that such annexation is necessary for the welfare of the residents and the property owners as a whole;

NOW, THEREFORE, as provided in 6-51-102(b) of Tennessee Code Annotated, the Board of Mayor and Aldermen of the Town of Spring Hill hereby proposes the annexation of the properties set forth in the attached First November 1987 Plan of Services which is hereby made a part of this Resolution.

BE IT FURTHER RESOLVED that the Plan of Services set forth therein is hereby proposed by the Board of Mayor and Aldermen and the same is hereby submitted to the Spring Hill Regional Planning Commission for study and written report to this Board within ninety (90) days from this date.
