**A RESOLUTION ADOPTING THE PLAN OF SERVICES  
FOR THE G. W. JONES PROPERTY  
AND A PORTION OF BUCKNER LANE**

WHEREAS, at a regular meeting of the Spring Hill Regional Planning Commission held on February 11, 1991, a study was conducted on this proposed Plan of Services and it was unanimously approved by that commission, which submitted its written report to the Board of Mayor and Aldermen; and

WHEREAS, a public hearing was scheduled on the proposed Plan of Services to be held before the Board of Mayor and Aldermen at 6:55 p.m. on Monday, February 18, 1991, and notice thereof was duly published in the Franklin Review Appeal and the Spring Hill Morning Sun; and

WHEREAS, pursuant to this notice, a public hearing was held before the Board of Mayor and Aldermen at 6:55 p.m. on Monday, February 18, 1991, and

WHEREAS, the Board of Mayor and Aldermen has considered the matters raised at the public hearing and has determined that the proposed Plan of Services should be approved;



PLAN OF SERVICES FOR THE G. W. JONES PROPERTY  
(WILLIAMSON COUNTY TAX MAP 154, PARCEL 65.03),  
CONTAINING APPROXIMATELY 4 ACRES,  
AND A PORTION OF BUCKNER LANE,  
UNDER CONSIDERATION FOR ANNEXATION  
TO THE TOWN OF SPRING HILL

The Board of Mayor and Aldermen of the Town of Spring Hill hereby proposes the following Plan of Services for the property of G. W. Jones (Williamson County Tax Map 154, Parcel 65.03, containing approximately 4 acres), and that portion of Buckner Lane between Buckner Road and the Thompson Station Road - Bethesda Road which is under consideration for annexation:

1. Police protection will be provided immediately upon the effective date of annexation. Fire protection, excluding fire hydrants, will be provided immediately upon the effective date of annexation.

2. Street lights, fire hydrants, garbage collection, water, electricity and sanitary sewer services, where not already provided, will not be provided by the Town of Spring Hill. If the Board of Mayor and Aldermen determines that Spring Hill has a sufficient water supply to serve the area, and only after such determination, waterlines may be extended to the area under consideration for annexation by the owners of the property at their expense. All other utilities, including fire hydrants, will be extended to the area under consideration for annexation by the owners of the property at their expense.

3. Garbage collection will be provided at the request of the residents of the area at their expense.

4. Road and street construction and repair:

Any new streets or roads within the area will be constructed at the expense of the owners of the property. Any state highways will continue to be maintained by the State of Tennessee. The portion of Buckner Lane to be annexed will be maintained by the Town of Spring Hill.

5. Recreational facilities:

The recreational facilities located within the Town of Spring Hill will be available to the inhabitants of the annexed area immediately upon the effective date of the annexation.

6. Zoning:

The area under consideration for annexation will be zoned as soon after annexation as can be reasonably accomplished.
