
WHEREAS, Spring Hill Police Department advertised a RFP for ten (10) Chevrolet Caprices; and

WHEREAS; City staff has reviewed prior proposals and has made a recommendation to the Budget and Finance Advisory Committee;



Passed and adopted by the Board of Mayor and Aldermen of the City of Spring Hill, Tennessee on the 21st day of February, 2017.




