

RESOLUTION NO. 97-21

**A RESOLUTION TO AWARD A CONTRACT TO  
JWV-KEY CONSTRUCTION COMPANY, INC, LEBANON, TENNESSEE  
FOR THE CONSTRUCTION OF A TEN INCH DUCTILE IRON  
WATER TRANSMISSION LINE FROM BUCKNER ROAD  
TO THE NEW NORTH SIDE WATER TANK SITE FOR A SUM  
NOT TO EXCEED \$206,112, WITH FUNDS TO BE DRAWN  
FROM THE MULTIPLE WATER/SEWER FUNDS AS MAY BE DETERMINED  
BY STAFF TO BE MOST APPROPRIATE**

**Whereas**, there is an immediate need to store more water on the north side for summer demand, fire protection, and state mandated reserves;

**Whereas**, bids for a new water transmission line from Buckner Road to the new water tank site were publicly requested, received and recorded, and JWV-Key Construction Company, Inc, Lebanon, Tennessee, was determined to be the low bidder at the total sum of \$206,112;

**Whereas**, at the date of adoption of this Resolution, it is still undetermined as to where the exact location of the construction of the transmission line may be;


**Whereas**, the exact location does not need to be known for the award of contract to be made since bid unit prices govern the amount owed by the Town for work done;

**Whereas**, the work must be done whether or not there is any developer agreement to participate in cost of the transmission line; and

**Whereas**, it is a consensus recommendation of the Town's engineer and staff that the ductile iron option, as a choice of pipe material, be selected for purposes of low maintenance and longevity.

**BE IT THEREFORE RESOLVED BY THE BOARD OF MAYOR AND ALDERMEN OF THE TOWN OF SPRING HILL, TENNESSEE** that a sum of money not to exceed \$206,112 shall be authorized to be paid for the construction of a ten inch ductile iron transmission line to run from Buckner Road to the new north side tank site, also to service HB&TS Utility District, and that the contract be awarded to JWV-Key Construction Company, Inc., Lebanon, Tennessee. Funds are to be drawn from the various water/sewer funds as staff may determine to be most appropriate at time pay requests are approved.
