

## **RESOLUTION 06-64**

### **A RESOLUTION OF SUPPORT FOR THE PROPOSED SPRING HILL HOSPITAL AND A REQUEST FOR MAURY REGIONAL AND WILLIAMSON MEDICAL CENTERS TO WITHDRAW THEIR APPEAL OF THE CERTIFICATE OF NEED APPROVED BY THE TENNESSEE HEALTH SERVICES AND DEVELOPMENT AGENCY ON JULY 26, 2006**

**WHEREAS**, Spring Hill is the second fastest growing City in Tennessee and its population is expected to double by 2011; and

**WHEREAS**, Spring Hill citizens currently have to travel more than 15 miles to reach a full-service hospital; and

**WHEREAS**, Spring Hill citizens do not have quick access to emergency care when needed; and

**WHEREAS**, TriStar has responded to the call from Spring Hill Officials to help address the needs of a growing population for comprehensive health care close to home; and

**WHEREAS**, TriStar hospitals offer high-quality healthcare for all patients, regardless of their ability to pay; and

**WHEREAS**, TriStar has offered to invest \$112 million to build a 56-bed full-service hospital and medical office building in the heart of Spring Hill on property where TriStar has a binding purchase contract; and

**WHEREAS**, the proposed hospital will create 300 new jobs with salaries and benefits totaling \$28 million annually and generate incremental property and sales taxes; and

**WHEREAS**, HCA/TriStar fosters a culture of inclusion and diversity across all areas of the company which embrace and enrich its workforce, physicians, patients, partners and communities; and

**WHEREAS**, there will be no cost to the City of Spring Hill or Maury County and its taxpayers to build the hospital or fund its operating costs on an ongoing basis; and

**WHEREAS**, more than 10,000 taxpaying citizens signed a petition to the Tennessee Health Services and Development Agency (HSDA) to request they approve the Certificate of Need for the Spring Hill Hospital; and

**WHEREAS**, HSDA, in an overwhelming 7 to 1 vote, approved the Certificate of Need for the Spring Hill Hospital on July 26, 2006; and

**WHEREAS**, Maury Regional and Williamson Medical Center are now using Public Funds to appeal the Certificate of Need and deny the citizens of Spring Hill the hospital they desire; and


**WHEREAS**, delays in constructing the Spring Hill Hospital will result in lost tax revenues to Maury County and lost impact fees to the City of Spring Hill; and

**NOW, THEREFORE BE IT RESOLVED** by the Board of Mayor and Aldermen of the City of Spring Hill, Tennessee, that it pledges its support of the proposed Spring Hill Hospital and urges Maury Regional and Williamson Medical Centers to immediately withdraw their appeal of the Certificate of Need.


