

RESOLUTION 08-39

**A RESOLUTION ACCEPTING THE
PAVING CONTRACT ADDENDUM
FOR MILES JOHNSON PARKWAY, PHASE II**

WHEREAS, the City of Spring Hill had previously contracted with Mid-Tenn Construction & Electrical Co., Inc. to provide certain work and material for Miles Johnson Parkway, Phase II;

WHEREAS, on September 15th, 2008 Mid-Tenn Construction & Electrical Co., Inc. requested that due to the extreme increase in materials, rock and oil its subcontractors were not able to honor their original bid and therefore Mid-Tenn requested that it be relieved of the remaining portion of the contract;

WHEREAS, the reduction to the contract price would be \$502,209.79;

WHEREAS, Tennessee Valley Paving Co., Inc. had a previous contract with the City for paving of Kedron Road and Buckner Lane and has agreed to perform the remaining work on Miles Johnson Parkway, Phase II, along with the City for the sum of \$656,523.00.

WHEREAS, the overall construction and paving price remains consistent with the cost of the roadway as presented to this Board by the City Engineer and City Manager in July 2008.



These revisions will reduce the total Contract Price (\$1,649,996.47 Base + \$10,127.56 Change Orders) of \$1,660,124.03 to \$1,157,917.57. as all other Items will remain in Contract.



WE HEREBY PROPOSE: To furnish in accordance with your Specifications and/or Drawings for the above named Project the following:

Rebid of Base Stone Only

Plans dated 6/20/07 specify 10" of limestone base on a section of Miles Johnson Parkway, approximately 4,400 feet long. The new roadway section is to be 24 feet wide, plus a 4 foot shoulder on each side, thus making the limestone base a total of 32 feet wide. Approximately 2,000 tons of limestone base has previously been placed.

This Quote is a per ton price for placing base stone on the section of Miles Johnson Parkway, as existed when inspected by Lester Malugin on 7/17/08. This quote includes no work on the section adjacent to Hwy. 31 that has been paved by others. This Quote is to place base stone no thicker than ten inches. There are areas that have been graded in such a manner that does not allow for 10" of base stone. There are some pipes that exist at elevations such that little or no base stone can be placed over the pipe and/or surrounding area. Also noted is that the improvement areas to Duplex Road may not match drawing contained in original plans.


Limestone base 32" wide will be installed for a per ton price. This includes no work on section adjacent to Hwy. 31 and no work on the section that has been paved by others. Limestone Base will be placed at depths ranging from 0" to 10" on graded sections from the end of the paved area near Hwy. 31, and extending to the end of the project at Old Kedron Road. Base stone will be installed to a level of 6" below top of manholes. Certified weigh tickets for base stone will be provided for quantity verification.

**ADDENDUM TO PAVING CONTRACT
OF MILES JOHNSON PARKWAY, PHASE II**

Comes now Mid-Tenn Construction & Electrical Co., Inc. and the City of Spring Hill and hereby agree to modify the existing paving contract of Miles Johnson Parkway, Phase II.

At the request of Mid-Tenn Construction & Electrical Co., Inc., by letter dated September 15th, 2008, attached hereto as Exhibit #1, it has been asked to be relieved of certain portions of the roadway base bid.

That such items include items #6 - #10, and more particularly described as follows:

- Roadway Item #6 - Compacted Crushed Stone Base
- Roadway Item #7 - Bituminous Tuck Coat
- Roadway Item #8 - Bituminous Prime Coat
- Roadway Item #9 - Type 307-B Asphalt Binder
- Roadway Item #10 - Type 411-D Asphalt Topping
- Roadway Item #11 - Curb and Gutter
- Roadway Item #17 - Installation of Standard T.D.O.T. Guardrail w/8 Flared Ends

Mid-Tenn Construction shall also be relieved of #19(a-h) in addition to the above referenced items.

That such revisions shall reduce the total contract price from \$1,660,124.03 (\$1,649,996.47 base, plus \$10,127.56 for change orders). That all other provisions of the existing contract between Mid-Tenn Construction and the City of Spring Hill, Tennessee not specifically changed by this Addendum shall remain in effect as previously agreed. The total contract price shall now be \$1,157,914.24.


It is agreed that Tennessee Valley Paving will perform the following work on Miles Johnson Parkway, Phase II:

The City of Spring Hill, Tennessee will purchase the estimated 9,800 tons of rock needed to complete the additional work to be performed by Tennessee Valley Paving.
