**A RESOLUTION AUTHORIZING AN EXPENDITURE FOR THE
INSTALLATION OF A NEW HEATING AND COOLING SYSTEM AT CITY
HALL, 199 TOWN CENTER PARKWAY**

WHEREAS, there is a critical need for a new Heating and Cooling System at Spring Hill City Hall, 199 Town Center Parkway; and

WHEREAS, the City of Spring Hill has advertised for proposals for the installation of a new Heating and Cooling System from licensed, qualified contractors by sealed bid, on or before 4:00 p.m., November 5, 2008; and

NOW, THEREFORE BE IT RESOLVED, by the Board of Mayor and Aldermen of the City of Spring Hill, Tennessee that an expenditure of approximately \$167,700.00 is hereby authorized for the installation of a new Heating and Cooling System from Sandrell Heating and Cooling, Columbia, TN, as recommended by staff after review of all bids.

BE IT FURTHER RESOLVED that the expenditure be drawn from both the General Fund and Water-Sewer Fund in equal portions.


