A RESOLUTION TO AUTHORIZE THE CONSTRUCTION OF A TRUCK GARAGE FOR THE FIRE DEPARTMENT


WHEREAS, the Fire Department is in need of a climate-controlled garage to store vehicles and equipment; and


WHEREAS, the City of Spring Hill advertised and received requests for proposals on August 9, 2010 from qualified contractors for this Fire Truck Garage as specified


