**WHEREAS**, the City of Spring Hill has included this project in its Capital Improvement Plan; and


**WHEREAS**, City Staff has recommended authorizing Dempsey Dilling and Associates to engineer the crossing of Interstate 65 for sewer service; and

**Passed and adopted by the Board of Mayor and Aldermen of the City of Spring Hill, Tennessee on the 18th day of July, 2011.**



(BY CITY)



Dear Ms. Goad:

As you have requested, I have written a scope of work which Dempsey, Dilling & Associates, P.C. is proposing for the two above referenced projects. This work is being proposed to be performed under our current engineering contract agreement with the City of Spring Hill.

**Hardin's Landing Water Storage Tank:** The proposed scope of work by Dempsey, Dilling & Associates, P.C. will consist of development of bid documents (engineered construction plans and specifications) to include a (0.75 or 1.0 MG) elevated water storage tank, tank site layout and design, approximately 1,000-feet of 18-inch water line design, hydraulic calculations, bid document submittal to TDEC, Construction Notice-of-Intent submittal to TDEC, and construction administration to include assistance with bidding and construction representation.

**East Side I-65 Sewer Extension:** The proposed scope of work by Dempsey, Dilling & Associates, P.C. will consist of development of bid documents (engineered construction plans and specifications) to include approximately 1,565-feet of 8-inch gravity sewer line, approximately 350-feet of 48-inch roadway bore and casing with 30-inch carrier pipe under I-65, approximately 365-feet of 30-inch gravity sewer line, approximately 235-feet of 8-inch gravity sewer line (to be connected to a lift station installed by others), hydraulic calculations, bid document submittal to TDEC, Construction Notice-of-Intent submittal to TDEC, submittal to TDOT, and construction administration to include assistance with bidding and construction representation.
