OF SUV FOR THE WATER TREATMENT PLANT**


WHEREAS, the Water Treatment Plant is in need of a Sport Utility Vehicle; and

WHEREAS, the City of Spring Hill accepted proposals from qualified vendors on April 27, 2012; and


WHEREAS, city staff have reviewed the proposals and made a recommendation to the Budget and Finance Advisory Committee; and


