and


WHEREAS, the City of Spring Hill approved funding of a Knuckle Boom

Advisory Committee; and


NOW, THEREFORE BE IT RESOLVED, that the City of Spring Hill,

of Spring Hill, Tennessee on the 20th day of August, 2012.**






