**A RESOLUTION TO AUTHORIZE THE DISPOSITION OF SURPLUS WEAPONS AND ACCESSORIES**

**WHEREAS**, the City of Spring Hill Police Department was awarded weapons and accessories by forfeiture from the Williamson County, TN Circuit Court and Maury County, TN Circuit Court; and


**WHEREAS**, TCA 39-17-1317 allows for disposition of confiscated weapons and section (l) provides for the exchange of firearms for legitimate law enforcement purposes between departments and a licensed and qualified law enforcement firearms dealer; and

**WHEREAS**, the City of Spring Hill authorized the trade of the following weapons and accessories to King's Tactical Firearms, Columbia, TN for credit on the purchase of weapons and/or equipment:
