**WHEREAS**, the Water Department is in need of a Mini-Excavator; and


**WHEREAS**, the City of Spring Hill approved funding of Mini-Excavator in the 2013-2014 fiscal year budget; and

**WHEREAS**, the City of Spring Hill advertised and accepted proposals from qualified vendors on August 28, 2013; and


**WHEREAS**, Staff has submitted a recommendation to the Budget Finance Advisory Committee; and
