OF HELMETS FOR THE FIRE DEPARTMENT**

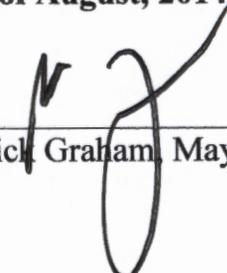
**WHEREAS**, the Spring Hill Fire Department is in need of 38 new helmets for the safety of firefighters; and

**WHEREAS**, the City of Spring Hill advertised and received bids for helmets on August 4, 2014; and

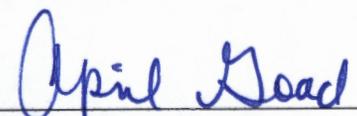
**WHEREAS**, City Staff has made a recommendation to the Budget Finance Advisory Committee; and

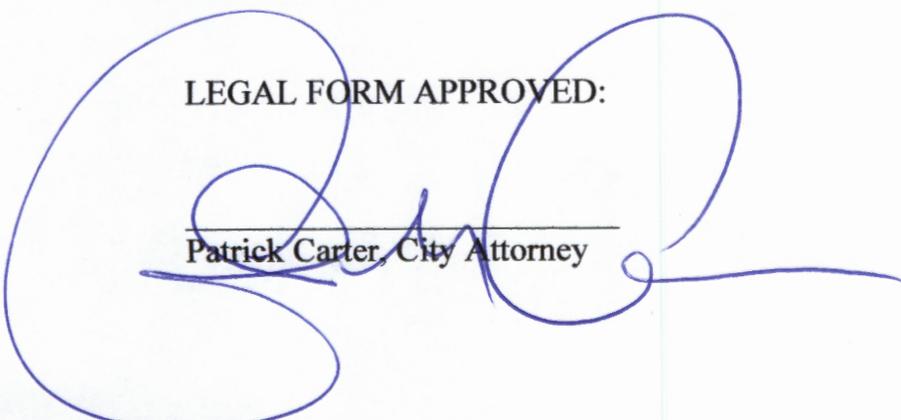

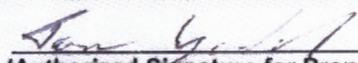
