WHEREAS, the Spring Hill Codes Department is in need to replace (1) 2001 Chevy 1500 and (1) 2000 Nissan Frontier truck with 2 new 2015 Chevrolet 1500 2WD pickup trucks, one with ancillary equipment; and

WHEREAS, the City of Spring Hill 2014-2015 budget included \$45,000.00 for the purchase of 2 vehicles, one truck requires a light bar and truck bed topper; and


WHEREAS, the City of Spring Hill Codes Department will use the State wide bid for the purchase for the pickup trucks with the cost for each at \$18,819.65; and

WHEREAS, the ancillary equipment, one truck topper at \$1,600.00 and one light bar at \$550.00 from a separate vender in the total amount of \$2,150.00

WHEREAS, City Staff has made a recommendation to the Budget Finance Advisory Committee.



Passed and adopted by the Board of Mayor and Aldermen of the City of Spring Hill, Tennessee on the 17th day of November, 2014.








