WHEREAS, the City of Spring Hill Board of Mayor and Aldermen desires to provide for the health, safety and welfare of its residents and visitors; and


WHEREAS, Rippavilla is owned as a non-profit, historic, tourist and special events destination that brings revenue from across the nation, adding value to our local economy; and


BE IT FURTHER RESOLVED, this resolution shall take effect from and immediately after its passage, the public welfare requiring it.

Passed and adopted by the Board of Mayor and Aldermen of the City of Spring Hill, Tennessee on the 20th day of October, 2014.




