
WHEREAS, the following vehicles are recommended to be either sold or donated: and



OVERVIEW: The Police Department has a surplus of older model police vehicles with high mileage and or mechanical issues and we are in need of disposing them.

BACKGROUND INFORMATION: All vehicles were purchased for the police department to be used either in patrol or CID. Three of the vehicles were purchased from the Departments Drug Fund and the proceeds from the sale of these vehicles will go back into the Drug Fund. The rest were purchased from the general fund. We will auction them off through Gov Deals, as we have done in the past. One vehicle will be transferred over to the IT department. The McKenzie Tn. police department is in need of assistance due to the economy of the city and a donation to their department of one or two vehicles would benefit Chief Moates and his department.

FINANCIAL IMPACT: proceeds from the sale will go back into the city budget and police drug fund account.

ALTERNATIVE OPTIONS: Spend a lot of money to repair vehicles to make useable for police operations. Mechanical issues with these cars. (Blown motor, front end replacement to include hub assembly, rack/pinion, motor mounts broken. Replace head gasket.) Other vehicles, due to age and mileage along with number of hours vehicles have from idling, may require future maintenance that is unknown at this time.

STAFF RECOMMENDATION: Sale vehicles on Gov Deals and donate to IT and McKenzie Police Department if they are still interested or in need.
