**A RESOLUTION TO AUTHORIZE PURCHASE OF PICTOMETRY AERIAL DATA**


**WHEREAS**, the City of Spring Hill has purchased aerial data from Pictometry International Corp, sole-source provider, in the past; and


**WHEREAS**, the quoted price for the Spring Hill portion of aerial data is \$17,849.00;



**PURPOSE:** Spring Hill GIS department participates in purchasing aerial data from Pictometry with Maury County. Last flight and data gathering was March 2013.

**BACKGROUND:** Spring Hill has participated with Maury County and Williamson County for several years in the Pictometry flights. Maury County is maintaining a three year flight cycle. Pictometry worked with Spring Hill to include the Williamson County city limits area. Pictometry also agreed to expanded aerial data collection to the east to cover Williamson County properties between I-65 to Lewisburg Pike at Spring Hill's request. This addition was added to the city's portion of the overall bill.

**FINANCIAL IMPACT:** Department budgeted for \$20,000 to cover the Williamson County portion, actual cost quoted at \$17,849.
