WHEREAS, the Spring Hill Police Department purchased a 2014 Chevrolet Impala, which was involved in a vehicular crash; and


WHEREAS, the Spring Hill Police Department was issued a settlement check in the amount of \$17,858.50 from the other parties insurance company to replace the Impala; and

WHEREAS, GMC of Murfreesboro has a State Contract for the Chevrolet Impala.




