



**RECOMMENDATION:**

Approval of two readings is required.

**BACKGROUND & INFORMATION:**

The Board of Mayor and Aldermen approved a Municipal Code update by American Legal Publishing LLC in September 2017, with the option of periodical updates. Updates are done yearly. This update is the 2025 S-6 Supplement which goes through Ordinance 25-14.

**USES AND APPLICATIONS**

The Spring Hill Municipal Code must be updated to include ordinances passed after previous codification. If approved, this will update the Spring Hill Municipal Code through Ordinance 25-14.

**FINANCIAL IMPACT:**

The cost for the update is approximately \$3,200.00 and is included in the current budget.
