
**A RESOLUTION TO AUTHORIZE BID AWARD FOR THE SANDBLASTING

Department Budget Status:

I. Purpose/Overview: To purchase Firefighting hose for structural firefighting during fiscal budget year.

II. Background Information: The fire department is allocated funding for sand blasting and painting of fire hydrants each fiscal budget year to comply with NFPA 291. Sometime back all fire hydrants were painted white and are now being painted red. We advertised an RFP, and two vendors responded, DMD Consultants Inc. and Preferred Sandblasting and Painting LLC. We based the selection on pricing, service and quality of work.

III. Financial Impact to Budget. \$22,420 budgeted for this work which is split between Fire Department and Public works.

IV. Alternative Options: another vendor.

V. Staff Recommendations: It is recommended to painting and sandblasting contract to DMD Consultants Inc., based on pricing, service provided, and quality of product.


