**A RESOLUTION AUTHORIZING THE REJECTION OF ALL BIDS FOR
NORTHFIELD ROOF REPAIR**

WHEREAS, the City of Spring Hill sought bids for the repair of the Northfield building roof; and

WHEREAS, two sealed bids were received by the City of Spring Hill and opened on January 31, 2019; and

WHEREAS, the two bidders were Baker Roofing Co. 1209 Northgate Business Pkwy, Madison, TN 37115, which submitted a bid in the total amount of \$137,867.00; Collier Roofing Co. Inc. 1523 Jones Avenue, Nashville, TN 37207, which submitted a bid in the total amount of \$58,430.00; and

WHEREAS, the bids were reviewed and it was determined that the bids exceeded the budgeted amount for the repair or did not accurately follow the scope provided; and

WHEREAS, the Board of Mayor and Alderman has recommended that all of the bids be rejected.

NOW, THEREFORE BE IT RESOLVED, by the City of Spring Hill Board of Mayor and Aldermen, that all bids received are rejected and the bidders will be notified.


