SPRAY PAINT FROM LOWE'S**


**WHEREAS**, Lowe's of Spring Hill, Tennessee desires to donate several boxes of nails and spray paint to the City of Spring Hill; and

**WHEREAS**, several departments within the City, including Public Works and Parks & Recreation will be able to use the donated items; and


**WHEREAS**, the items being donated are valued at \$848.
