
WHEREAS, there is a critical need to maintain software for various Tyler Technologies programs; and

WHEREAS, the City of Spring Hill utilizes Tyler Technologies programs for Finance, Utility Billing, Payroll, EnerGov Permits and Public Safety per Resolution 13-100, authorizing purchase of software and subsequent resolutions authorizing the purchase of supplemental products.

NOW, THEREFORE, BE IT RESOLVED, by the Board of Mayor and Alderman of the City of Spring Hill, Tennessee that an expenditure of approximately \$213,000 is hereby authorized for FY 2020-2021 annual software maintenance and support.
