**A RESOLUTION APPOINTING A JUDGE TO SERVE THE SPRING HILL
MUNICIPAL COURT**

WHEREAS, the current Municipal Judge has given her notice of separation and her last scheduled trial docket was August 16, 2022; and

WHEREAS, the City of Spring Hill desires to appoint a new Municipal Judge.

NOW, THEREFORE, BE IT RESOLVED, by the Board of Mayor and Aldermen of the City of Spring Hill that Nichole Dusche, Esq., is hereby appointed to the at-will position of Judge for the Spring Hill Municipal Court to serve at the pleasure of the Board of Mayor and Aldermen. Rate of pay will be \$28,007.16 annually, not subject to yearly employee increases or employee benefits. In his/her absence, Judge Dusche may appoint a qualified designee as substitute.

BE IT FURTHER RESOLVED, that this appointment shall become effective beginning September 6, 2022.

Passed and adopted by the Board of Mayor and Aldermen of the City of Spring Hill, Tennessee, on the 6th day of September, 2022.




